#### **INFORMATION ABOUT PROPOSALS**

#### PROPOSAL 20-1

The proposed constitutional amendment would:

- Allow the State Parks Endowment Fund to continue receiving money from sales of oil and gas from state-owned lands to improve, maintain and purchase land for State parks, and for Fund administration, until its balance reached \$800,000,000.
- Require subsequent oil and gas revenue from state-owned lands to go into the Natural Resources Trust Fund.
- Require at least 20% of Endowment Fund annual spending go toward State park improvement.
- Require at least 25% of Trust Fund annual spending go toward parks and public recreation areas and at least 25% toward land conservation.

Should this proposal be adopted? YES PROPOSAL 20-2

This proposed constitutional amendment would:

- Prohibit unreasonable searches and seizures of a person's electronic data and electronic communications.
- Require a search warrant to access a person's electronic data or electronic communications, under the same conditions currently required for the government to obtain a search warrant to search a person's home or seize a person's things.

Should this proposal be adopted? YES

SERVICES FOR THE AGED PROVIDED

THROUGH MANISTEE COUNCIL ON AGING

Manistee County Council on Aging is seeking a renewal of its milage 0.300 mills to provide services to Manistee County seniors 60 and over. Manistee County Council on Aging is also requesting a new additional milage to provide the Senior Nutrition Program (Meals on Wheels) to Manistee County homebound seniors and congregate meal sites in the amount of 0.178 mills. If approved the total milage in the amount of 0.475 would go to the Manistee Council of Aging for six (6) years.

Absentee Voting: Please know that ballots should be mailed out by September 24-25<sup>th</sup> to voters that have applied for them. If you haven't applied for an absentee ballot <u>do so now</u> by going online to complete an application at <a href="https://www.mi.gov/vote">www.mi.gov/vote</a> or call your township or city clerk to request one. Once you have applied for a ballot, the ballot will be mailed to you. REMEMBER TO SIGN YOUR NAME TO OUTER SIDE OF THE ABSENTEE BALLOT. You can check your ballot status at: <a href="https://www.mvic.sos.state.mi.us/voter">www.mvic.sos.state.mi.us/voter</a>

Your ballot must be returned to your township or city clerk by November 3<sup>rd</sup>. Be sure to mail your ballot no later than October 20<sup>th</sup>. Another option is to return your ballot directly to the clerk or put it in a secure drop box or mail slot. See locations below:

## Benson: Michigan could see up to 70% percent turnout in November

Secretary of State Jocelyn Benson on Wednesday predicted more than 5 million Michiganders will vote in the presidential election and said she expects more than 3 million will do so by absentee ballot.

That would nearly double the record 1.6 million absentee ballots cast in the August primary and rival total turnout from the 2008 presidential election. Already, 2.3 million Michigan registered voters have requested absentee ballots, said Benson, adding she expects about 60 percent to 70 percent of the state's 7.5 million voters to cast ballots.

Michiganders voted to expand absentee voting in 2018, and the coronavirus pandemic has likely spurred additional interest in the option. But voters can still cast ballots in-person on Nov. 3, Benson reminded.

"When you do show up on Election Day at your local precinct, you will be greeted by workers wearing masks, gloves and face shields," she said in a COVID-19 news conference with Gov. Gretchen Whitmer. "You will find the precinct to be sanitized with social distancing guidelines in place."

Benson, Michigan's top election official, thanked the Senate for approving legislation on Tuesday, September 15, that would allow clerks to open absentee ballot mail envelopes a day early to prepare them for counting on Election Day. If approved by the House, clerks hope the pre-processing will help them report election night results in a timely fashion.

But Benson wants to give clerks more time and implored the Legislature to do more to ensure every vote is counted, such as allowing absentee ballots that are postmarked by Election Day to be tabulated even if they arrive by mail a day or two late.

Benson has repeatedly rebutted President Donald Trump's claim that mail-in voting is unreliable and will lead to voter fraud. On Wednesday, she warned that the state is expecting efforts to mislead or misinform Michiganders about their legal voting options and announced a new reporting email address: <a href="mailto:misinformation@michigan.gov">misinformation@michigan.gov</a>.

"If you see or hear anything suspicious, anything that sounds wrong or that is just plain confusing about your right to vote this year, report it to my office," Benson said.
