## COMMENTS FROM THE CHAIR

I hope this newsletter finds everyone safe and healthy during this unprecedented public health emergency. Thankfully, most citizens in our area are practicing behaviors that are proven effective against this virus and following the guidelines ordered by the state. So far, we have seen very few cases of the infection in our part of the state. We all need to continue behaving responsibly so that the whole community can remain safe. I was very disturbed by the comments of the four sheriffs in our region that were publicly released on April 15. As elected public officials they have a sworn duty to uphold the law and to serve the public's best interests in keeping us all as safe as possible. By picking and choosing which laws to enforce and which to ignore, they are communicating a dangerous message to the public and setting a poor example of how

Gary Madden government officials should behave in office.

Law enforcement officials have always had discretion in applying the law. When stopping a motorist for driving 5 mph over the speed limit, for example, they can issue a ticket or give a warning. Publicly announcing that they will not enforce speed limits only encourages drivers to ignore speed limits and thereby make our roads more dangerous than they already are. This puts everyone at risk. Similarly, announcing that certain restrictions will be ignored by law enforcement sends a dangerous message that can only result in more people being exposed to this highly contagious virus.

Like it or not, we are literally and irrevocably, in this health crisis together. We are highly social beings that depend on each other for our very lives. Too often we forget about the connections we have to other people and how fundamentally important they are to our everyday well-being. If there is a positive side to this pandemic, it is a reminder to us of just how connected and dependent we are on each other and other people around the world. How we behave as individuals effects the whole of humanity. It is this social power that is the driving force behind our success as a species. To place our imagined individual rights above the health and safety of our community is suicidal. Yet that is exactly what these sheriffs have done. The right to rake our lawn, go fishing, or put our boats in the water should not be more important than public safety.

This emergency has come upon us very quickly and has called for rapid responses from leaders at all levels, especially in the areas of health services and government. By now it is abundantly clear that we were not fully prepared. Restrictions had to be devised and communicated to the public very quickly. In such an environment, some restrictions were probably not thoroughly thought out with all implications considered or all bases covered. Its not unreasonable for those who have to enforce restrictions to have doubts or objections about them. The proper way to deal with such a situation is to communicate concerns to higher authorities so that policies can be reasonably adjusted or reevaluated. Our sheriffs instead chose to go public with their objections and act in defiance of the Governor's orders, accusing her of "overstepping her authority." This kind of open defiance is shameful and should not be forgotten by voters in November when it is time to elect a new county sheriff.

In their statement, the sheriffs seem more concerned with getting the economy opened so that businesses can resume making money than with public safety. It is true that the current situation places a great burden on working people and businesses. It is also likely that many more people will die or become seriously ill if we all resume our normal activities too soon. Many experts in science and medicine have warned that the viral pandemic could worsen if we reopen too soon.

Finally, you have to wonder why these and other sheriffs around the state have behaved so irresponsibly in ignoring the common good. My own feelings are that they have simply taken a page out of the Republican playbook to politicize a major national health crisis. You know, the page about divide and conquer. Instead of trying to face this crisis with unity and purpose, they are trying to make this a personal rights issue, a position guaranteed to divide us along political lines. Perhaps this is their way of supporting Donald Trump and his eagerness to resume business as usual with a casual disregard for the lives of citizens. What does that say about our national values and the importance of human life? If you believe, as I do, that the health, well-being, and safety of people ought to be our first consideration in response to this pandemic, it should be our duty to communicate our displeasure with this shameful declaration from our sheriff. #### TRUMP'S MISSTEPS HAVE MADE THE NATION MORE VULNERABLE

In a time when protecting the nation's public health demands clear, truthful and compassionate leadership, President Donald Trump has offered exactly the opposite. He is a clear and present danger to the nation's public health, and he should resign immediately.

Trump has dissembled about the seriousness of the coronavirus epidemic, either because he refuses to accept the truth or fears the effect on his political fortunes, or both. Months too late, he has finally started to acknowledge that the crisis is real, serious and likely to persist.

Trump repeatedly has refused to make science-based recommendations or to declare a public emergency, reportedly out of fear about the effect on the stock market. It turns out that denying the truth visible to all doesn't fool the market; and in fact when Trump did finally declare a public health emergency, markets responded positively.

Trump has misstated his administration's own policies, making multiple material misstatement in just one national address, wreaking havoc across the world. In that address, he stated there would be a ban on European cargo imports, which would have massively disrupted the global economy and in fact has not been imposed.

He also failed to make clear that Americans in Europe would be permitted to return home, sparking a pointless, desperate scramble and emotions turmoil for countless Americans who sought a plane back to the United State before new travel restrictions kicked in. (In fac, the restrictions don't stop American from returning home.)

Trump has presided over an administration that inexplicably has failed to deliver vitally need coronavirus tests to health care providers around the country and then repeatedly lied to or misled the American public about remedying the problem. Instead of taking responsibility for the problem and fixing it, Trump has bizarrely blamed it on his predecessor, Barack Obama. "No, I don't take responsibility at all," says Trump.

This testing failure may be the single most consequential human factor responsible for the spread of the disease. It has been impossible for public health authorities to calibrate appropriate responses without a clear understanding of COVID-19 incidence in the United States. Even now, public health experts are merely guessing about the actual extent of disease spread in the United States.

Beyond the testing debacle, there has been a shocking lack of leadership from the federal government under Trump. Governors and local authorities have stepped into the gap, but they are desperate for federal leadership. It has not been forthcoming. With states seeking federal assistance in providing the equipment needed to treat COVID-19 patients. Trump replied, "Try getting it yourselves."

Even for Trump, this Marie Antoinette response was shocking.

#### Governor's Executive Order 2020-42

Many of you may have seen news reports of lawsuits challenging the Governor's Executive Order 2020-42, issued April 9, 2020 – commonly referred to as a "stay at home" order. Limited time and space don't permit a detailed discussion of the merits of the challenge to the Order, but it may be helpful to collect the relevant constitutional and statutory provisions to facilitate discussion of the issues.

It appears that the lawsuits rely on the First and Fifth amendments to the US Constitution. Regarding the First Amendment, the lawsuits presumably relies on the right to assemble clause:

<u>"Congress shall make no law</u> respecting an establishment of religion, or prohibiting the free exercise thereof; or <u>abridging</u> the freedom of speech, or of the press; or <u>the right of the people peaceably to assemble</u>, and to petition the Government for a redress of grievances."

The Fifth Amendment has a number of provisions, most of which are irrelevant to the current claims. The arguably applicable one is the Due Process Clause:

"No person shall . . . be deprived of life, liberty, or property, without due process of law; . . . "

It is worth noting that historically these provisions did not apply to the States. However, the Fourteenth Amendment created at Due Process Clause that does apply to the States, and later court decisions have applied the First amendment. See <u>DeJonge v. Oregon</u>, <u>299 U.S. 353</u> (1937).

Like other rights recognized by the Constitution, these are not absolute. States have broad police powers that can be used to protect the public, particularly in the context of public health:

"[T]he liberty secured by the Constitution of the United States to every person within its jurisdiction does not import an absolute right in each person to be, at all times and in all circumstances, wholly free from restraint. There are manifold restraints to which every person is necessarily subject for the common good. On any other basis organized society could not exist with safety to its members."

Jacobson v. Massachusetts, 197 U.S. 11 (1905).

We should also keep in mind that the Executive Orders are not things that the Governor just makes up out of some claimed inherent power. The Legislature has enacted the Emergency Management Act, which authorizes the Governor to declare a state of emergency: "(1) During times of great public crisis . . . . when public safety is imperiled . . . the governor may proclaim a state of emergency and designate the area involved. After making the proclamation or declaration, the governor may promulgate reasonable orders, rules, and regulations as he or she considers necessary to protect life and property or to bring the emergency situation within the affected area under control. Those orders, rules, and regulations may include, but are not limited to, providing for the control of traffic, including public and private transportation, within the area or any section of the area; designation of specific zones within the area in which occupancy and use of buildings and ingress and egress of persons and vehicles may be prohibited or regulated; control of places of amusement and assembly and of persons on public streets and thoroughfares; establishment of a curfew. . . . " Michigan Complied Laws § 10.31

And the Emergency Powers of the Governor Act provides: (1) The governor is responsible for coping with dangers to this state or the people of this state presented by a disaster or emergency. (2) The governor may issue executive orders, proclamations, and directives having the force and effect of law to implement this act. MCL § 30.403 That statute says that an emergency declaration by the Governor is only effective for up to 28 days, unless it is extended by the Legislature. In this case on April 7 the Legislature did extend the declaration. Senate Concurrent Resolution No. 24.
